**Marketplace**

- Dates:** Friday, June 19 - Saturday, June 20, 2020. (Although Liberty Fest runs Thursday-Saturday, please note that the Marketplace is only open Friday & Saturday.)
- Hours:** Friday: 4 p.m. - Dusk Saturday: 10 a.m. - Dusk  
Vendors report the highest volume of sales and exposure between 7-10 p.m. on Saturday prior to the fireworks when the largest crowds occur.  
**There is no rain date and no refunds will be issued for inclement weather.**
- Location:** Heritage Park - vendor location(s) within the park and festival grounds are to be determined by the Liberty Fest Committee.
- Permits:** If applicable, vendors will be required to provide proof of all necessary permits and insurance(s). Each exhibitor is responsible for securing any applicable local, county, state permits/licenses.
- Fees:** Application fee includes one 8 foot table, 2 chairs and one 10'x10' tent.
