



## **RESIDENTIAL POOL AND HOT TUB** **COMPLIANCE APPLICATION CHECKLIST- 2015 MRC**

This list is provided as a guide to help you understand the information that must be contained on the construction drawings. This list is not all-inclusive of all building codes but is used as a general guide for plan review.

### **Licenses:**

**Contractor's must register their Residential Builder's License with the township online.  
Homeowner's may use the Homeowner's Permit Application.**

### **General**

- All drawings shall be completely dimensioned in duplicate (one copy is 11" x 17" or less in size)
- Drawn to scale not less than 1/8" = 1'0" or 1:20 for plot plans
- Drawing shall be prepared on sheet paper size no smaller than 8-1/2" x 11".
- Complete scope of work must be clearly identified for all phases of construction, indicating compliance with the current edition of Michigan Residential Code.

### **Application submittal requirements:**

- Pool permit application
- Minimum \$40.00 administration fee. Plan review and permit fees to be applied when permit is approved.
- Submit (1) copy of a plot plan sealed by licensed surveyor with the pool or hot tub located with dimensions from all structures. Plot plan may be available upon request. Email [bina.shah@canton-mi.org](mailto:bina.shah@canton-mi.org) to request.
- Submit (1) copy of all architectural drawings -(2) copies required for drawings over 11" x 17".
- Provide copy of homeowner association approval (if applicable)
- (1) copy of Pool manufacturer specifications
